Dear Mr. Speaker:

On behalf of the President, I am transmitting to the Congress a request for \$87.6 billion in supplemental funding. Most of this request will address urgent needs related to Operation Epic Fury (OEF), in addition to other critical needs such as responding to the Ebola outbreak in Central Africa and supporting hardworking American farmers.

Under President Trump's leadership, the United States executed a successful operation to deter the threat of a nuclear armed Iranian regime and massively degrade the regime's ability to project power in the region. Accordingly, the Administration's request addresses operational costs incurred by the Department of War (DOW) during OEF, including funding for military personnel and readiness expenses, operational costs to rebuild stocks expended by DOW, classified programs, and other key expenses. The request also provides \$21 billion for DOW to support critical capabilities, munitions procurement, and strengthen the U.S. industrial base.

In addition to supporting OEF costs incurred by DOW, the request provides \$768 million to the Department of Energy to support nuclear and other energy security requirements, primarily for the National Nuclear Security Administration for OEF-related activities. Additional funding is also requested for the Department of State (State) to address OEF-related costs, which would address security for State personnel and facilities and embassy security, construction, and maintenance. Further, funding is requested for costs the U.S. Coast Guard incurred as it supported DOW in the Western Hemisphere while DOW was executing OEF.

Beyond the urgent needs arising from OEF, the Administration is also requesting funding to address other crucial needs. Notably, this request includes \$1.4 billion in funding to respond to the Ebola virus outbreak in Central Africa. These funds would be used to limit the spread of Ebola beyond the Democratic Republic of the Congo and Uganda to other vulnerable nations and ensure the virus does not reach U.S. shores.

In addition, this supplemental request includes an additional \$11.1 billion to support American farmers. This includes \$10 billion in temporary economic assistance for row and specialty crops planted in crop year 2026. An additional \$1.1 billion is requested to help the State of Florida's agricultural producers to rebound from devastating losses that were the result of crippling storms this past winter.

The Administration also requests \$500 million to support ongoing efforts to complete restoration and construction projects in and around Washington, D.C., \$1 billion to assist in the final design and construction of a modernized Penn Station in New York City, \$600 million to support the General Services Administration, and \$1 billion to increase the benefit levels for participants of certain pension plans that were sponsored by Delphi Corporation and terminated as a result of General Motors' bankruptcy in 2009.

Furthermore, the Administration requests additional authorities that it strongly supports. These authorities include revising the Federal regulation of hemp to ensure the fair treatment of hemp products in a manner consistent with Amendment #54 offered to H.R. 8646 in the House Rules Committee, or, at minimum, an extension of implementation of the regulatory framework put in place by Section 781 of Public Law 119-37. They also include an urgent and needed fix that codifies the permanent, year-round sale of E-15; adding flexibility to funding provided by the Working Families Tax Cuts Act for the Administration's Brand New Air Traffic Control System initiative; increasing loan limits for small manufacturers; additional flexibilities for State; and removing a statutory barrier to the Development Finance Corporation supporting investments in Venezuela.

The enclosed table enumerates the request by agency and account. I urge the Congress to take action on these important and urgent requests as soon as possible. The Administration is also open to discussing additional relief for other urgent matters. I stand ready to work with you for the benefit of the American people.

The request prioritizes \$850 million for the Department of State's Counter-Unmanned Aircraft Systems program at high-risk posts, and security upgrades and equipment replacement. The request includes \$21 million for the Department as part of a classified request.
Embassy Security, Construction, and Maintenance	300,000,000	This request includes \$300 million to the Embassy Security, Construction, and Maintenance (ESCM) account. Funding would be used to address needs following Operation Epic Fury, including in Bahrain, Dubai, Karachi, Lahore, Riyadh, and others. These amounts are in addition to the up to \$1 billion currently allocated in the ESCM fiscal year 2026 Operating Plan to address Operation Epic Fury.

These funds would support contact tracing, personal protective equipment and commodity procurement, disease surveillance, laboratory capacity, and cross-border coordination.

Department of State General Provisions	The Administration requests that the Congress provide authority for funds made available under the headings “Economic Support Fund,” “Assistance for Europe, Eurasia and Central Asia,” and “National Security Investment Programs” in the fiscal year 2026 and prior year appropriations acts to be used, notwithstanding any other provision of law, to establish and operate enterprise funds in foreign countries in line with, but not geographically restricted to, the relevant provisions of section 201 of the Support for East European Democracy (SEED) Act of 1989. This authority would provide the legal framework for these funds to be used to establish and operate enterprise funds, proven, agile tools which would support private sector development, promote economic stabilization, and facilitate job creation in eligible foreign countries undergoing political or economic transition. Granting this authority would allow the Department to respond rapidly to emerging opportunities or crises where traditional assistance mechanisms may be less effective or too slow.
