



FY07 Emergency Supplemental Appropriations - Selected provisions added
by the House of Representatives Appropriations Committee

Title I. Supplemental Appropriations for the Global War on Terror

\$150M - Acquisition of Aircraft and Facilities for the Northern Border p181 (report)

\$1.25B Transportation Security Administration "Aviation Security" p181 (report)

Title II. Additional Hurricane and Disaster Relief

Chapter One:

Sec. 2101 \$25 million for the 2005 Hurricanes Livestock Indemnity Program (additional compensation to livestock producers affected by Hurricanes Katrina and Rita)

Sec. 2102 \$15 million for financial assistance for 2005 and 2006 irrigated corps losses due to saltwater intrusion from Hurricanes Katrina & Rita

Sec. 2103 \$100 million to resume 2005 Hurricanes Citrus Program to provide additional compensation for citrus producers affected by the Hurricane Katrina or Rita.

Chapter Two:

\$120 million for the National Oceanographic and Atmospheric Administration to for Hurricane Katrina impacts on the shrimp and menhaden fisheries to scan and map traditional fishing grounds and for debris removal.

\$35 million for NASA for risk mitigation (hurricane) at the Stennis Space Center (MS) p208 (report)

\$47.6 million for NASA to pay back monies loaned from the Space Shuttle/International Space Station (ISS) programs.

Chapter Three:

\$37 million for the Corps of Engineers to construct the Mississippi Coastal Improvements Project for Hancock, Harrison, and Jackson Counties, MS. This project has not yet been approved by congress.

Title III Agricultural Assistance

Sec. 3101 \$1.8B Crop disaster assistance for the 2005, 2006 or 2007 calendar years (2007 only up until the bill is passed). Producer select the year. p99 (bill) and p239 (report)

Sec. 3102 \$1.5B Livestock assistance for producers affected by wildfire (Texas and other States) and blizzards (Colorado, Kansas, Nebraska, New Mexico, and Oklahoma) for the 2005, 2006 or 2007 calendar years (2007 only up until the bill is passed).p107 (bill) and p239 (report)

Sec. 3103 \$25 million for spinach growers (to help them recover from selling contaminated spinach) p112 (bill)

Sec. 3104 \$20 million for Emergency Conservation Program for the cleanup and restoration of farmland damaged by freezing temperatures at any time between January 1, 2007 and the enactment of this bill.

Sec. 3107 \$283 million for the Milk Income Loss Compensation Program (MILC) p115 (bill)

Sec. 3109 \$5 million for aquaculture (to help them recover from importation ban b/c of outbreaks of viral hemorrhagic septicemia) p116 (bill)

Sec. 3108 \$74 million for the storage, handling and other associated costs for the 2007 crop of peanuts to ensure proper storage of peanuts. This funding shall only be available after September 30, 2007. p115 (bill)

Sec. 3109 \$5 million to compensate aquaculture operations in the business of breeding, rearing or transporting live fish to cover the economic losses incurred by the emergency order prohibiting importation of certain live fish from Canada and the movement of the same fish in the U.S. due to outbreaks of viral hemorrhagic septicemia.

Title IV. Other Matters

Chapter Five:

\$100M for future wildfire suppression by the Bureau of Land Management p215 (report)

\$400M for future wildfire suppression by the Forest Service p216 (report)

Sec. 4501 \$400M for county payments - renews program that expired in 2006 that provides funding for roads and schools in areas that used to receive funding from timber sale revenue. p216 (report)
